7.4. Finance Committee

Mr. Barneby distributed a new Budget Calendar. The first budget workshop will take place on December 10. If needed, the Finance Committee will meet on December 17, prior to the second budget workshop that same evening. Budget workshop #3 will take place on January 7 with the Board possibly taking action that evening, with an alternate date of January 21.

7.6. Policy Committee

The Policy Committee met this evening. Mr. DeSantis reported the following:

- Preliminary discussions were held regarding Policy #5110.4 –
 Suspension/Expulsion/Exclusion from School and School Activities, as well as Shipman & Goodwin's recommendations for the 1000 Series policies.
- For the current school year, the committee voted to recommend a graduation date of June 15, 2020.
- A few points of interest regarding the 2020-2021 school year: the school year begins prior to Labor Day (August 31) and there are 2 holidays that fall on a weekend. The current version of the 2020-2021 calendar consists of 188 teacher days and 182 student days. The committee is proposing the addition of Friday, March 12, 2021 as a day off for staff & students and adding a professional development day on June 14, 2021. This would retain the obligatory 188 teacher days and decrease the student days by one day (still fulfilling the 180 day requirement). The committee also discussed the April break.

Further discussions will take place at the December 17th board meeting.

7.7. LEARN Liaison

The LEARN Board of Directors met on November 14, 2019. CABE General Counsel gave a legislative update, discussing goals of the Advisory Commission of Intergovernmental Relationships. These goals include looking into shared services and increasing collaboration among school boards, reviewing healthy school start times, non-medical exemptions for vaccinations, social emotional learning, school climate policy, and special education funding.

LEARN leadership continues to meet with district superintendents to discuss their needs, their goals and how LEARN can assist. A task force will be addressing birth to five issues, and LEARN will host an early childhood symposium in December, called Keep Calm, Keep LEARNing. The LEARN Director of Innovation and Development continues to work on sub-regional transportation and has coordinated a collaboration with Waterford, East Lyme and Salem regarding a uniform contract to bid together. Roundtable topics include health insurance consortiums, high school start times and more discussion about regionalism and shared services.
