4.3. Daniel Hand High School Student Presentation - Results from the Search Institute Survey - Profiles of Student Life: Attitudes and Behaviors

Superintendent Scarice and 4 students from Daniel Hand High School shared the results of the Search Institute Survey taken last fall by all DHHS students with the Board of Education. Since late April/early May, Superintendent Scarice met with the four students on a weekly basis.

The students did not want this to be a typical presentation, but one that will wake up their peers, and wake up the adults in the community so that they accept that this is not a school problem, a parent problem, a MYFS problem, but perhaps the most vexing and critical problem that will face this entire community.

This is a topic that the District will continue to talk about and work on.

4.4. 5 year CIP/10 year Capital Maintenance Plan Presentation Bill McMinn

> Bill McMinn reviewed the documents of the 5 year CIP/10 year Capital Maintenance Plan Presentation for the Board one last time, prior to the vote to adopt later in the meeting. The 10+year capital maintenance plan was necessitated by the failed building referendum last September. However, an updated 5 year CIP plan is an annual action item for the BOE as the CIP recommendations are due for submission by July 1 each year.

The Board of Finance met earlier this evening. The committee reviewed the status of the 2017-18 budget. The District is looking at a projected deficit of \$100,057, which is largely driven by Special Education costs. This is roughly 20,000 more than we requested from the Special Ed Reserve Fund so we may need to request additional funds. The books close as of 6/30, however we leave them open for the month of July so we can reconcile any last invoices. Galen provided the Finance Committee with a report from the Facilities committee re: the 10 year plan and 5 year CIP.
